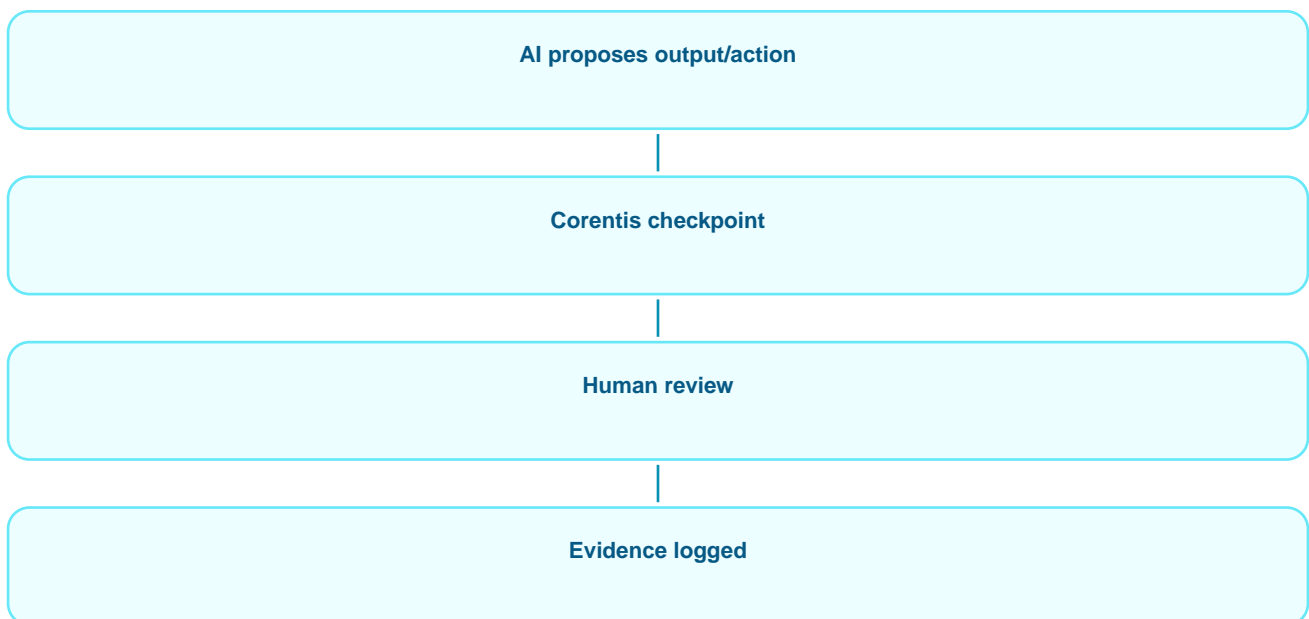

Why the next 90 days matter

The next 90 days should turn Corentis from a strong public proposition into a focused validation programme: conversations, scenario assets, evidence outputs and pilot readiness.

Days 1-30: sharpen proof and conversations

The first month should focus on launch quality and the first serious conversations.

- Review the public PDF pack and website journey.
- Use the investor and design-partner packs in targeted conversations.
- Define the first scenario families for complaints and vulnerable customers.
- Prepare the ControlBench validation outline.
- Capture feedback from the first conversations.

Days 31-60: validate the wedge

The second month should turn conversations into sharper validation design.

- Refine the workflow boundary.
- Map policy intent into structured controls.
- Draft the first scenario library.
- Design baseline versus checkpoint workflow tests.
- Agree what evidence a pilot report should show.

Days 61-90: turn conversations into pilot evidence

The third month should move toward controlled pilot readiness.

- Run sample scenarios through the checkpoint model.
- Score evidence completeness and review routes.
- Refine the control matrix.
- Create sample pilot outputs.
- Decide whether to progress to a larger controlled pilot.

Outputs expected

Expected outputs include a scenario library, control schema, evidence scoring method, sample pilot report, investor/funder conversation notes and a clearer design-partner pilot plan.

Useful decision gates include whether the workflow is narrow enough, whether reviewers understand the checkpoint decisions, whether evidence is clear enough, and whether the next pilot stage is worth pursuing.

What momentum looks like

Momentum means better conversations, clearer scenarios, stronger evidence artefacts and a focused path toward validation. It does not require inflated claims.
